# Disturbance decoupled estimation for linear differential-algebraic systems

#### Abstract

We study the disturbance decoupled estimation problem for linear differential-algebraic systems which are not necessarily regular. We introduce the notion of partial state observers following a recent approach to observer design motivated by considerations for behavioral systems. In our framework, a partial state observer is itself a differential-algebraic system. We derive a characterization for existence of (asymptotic) partial state observers. Exploiting the freedom in the proposed observer design, we derive a solution of the disturbance decoupled estimation problem. The characterization of solvability is obtained via geometric conditions in terms of the generalized Wong sequences.

## 1. Introduction

We study linear time-invariant systems (the plant) given by differential-algebraic equations (DAEs) of the form

where $E, A \in \mathbb{R}^{l \times n}, B \in \mathbb{R}^{l \times m}, C_{i} \in \mathbb{R}^{p_{i} \times n}, D_{i} \in \mathbb{R}^{p_{i} \times m}, i=1,2$. Systems of that type are also called descriptor systems. The set of DAE systems (1) is denoted by $\Sigma_{l, n, m, p_{1}, p_{2}}$ and we write $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$. Systems of the form (1) occur when modeling dynamical systems subject to algebraic constraints; for a further motivation see Berger (2014); Brenan, Campbell, and Petzold (1989); Kunkel and Mehrmann (2006); Lamour, März, and Tischendorf (2013); Riaza (2008) and the references therein. In the present paper we do not assume that $s E-A$ is regular, which would mean that $l=n$ and $\operatorname{det}(s E-A) \in \mathbb{R}[s] \backslash\{0\}$.

The functions $u: \mathbb{R} \rightarrow \mathbb{R}^{m}, y: \mathbb{R} \rightarrow \mathbb{R}^{p_{1}}$ and $z: \mathbb{R} \rightarrow \mathbb{R}^{p_{2}}$ are called input, measurement output and controlled output of the system (1), resp. The measurement output $y$ contains those variables which can actually be obtained from measurements, e.g. via sensors, and the controlled output $z$ contains those variables for which a desired behavior should be achieved (as an additional control task) and hence estimates are required for them. The outputs $y$ and $z$ do not

[^0]coincide in general. We call $x: \mathbb{R} \rightarrow \mathbb{R}^{n}$ the state although, strictly speaking, $x(t)$ is in general not a state in the sense that the free system (i.e., $u=0$ ) can be arbitrarily initialized (Knobloch \& Kwakernaak, 1985, Sec. 2.2); however, $x(t)$ contains the full information about the system at time $t$. The tuple $(x, u, y, z): \mathbb{R} \rightarrow \mathbb{R}^{n} \times \mathbb{R}^{m} \times \mathbb{R}^{p_{1}} \times \mathbb{R}^{p_{2}}$ is said to be a solution of (1), if it belongs to the behavior of (1):

DAE control systems based on the above behavior have been studied in detail e.g. in Berger (2014). For the analysis of DAE systems in $\Sigma_{l, n, m, p_{1}, p_{2}}$ we assume that the states, inputs and outputs of the system are fixed a priori by the designer. This is different from other approaches based on the behavioral setting, see Berger and Van Dooren (2015); Campbell, Kunkel, and Mehrmann (2012).

Observer design for general differential-algebraic systems has been investigated recently in Berger and Reis (2015a). It is revealed that there is still a lot of freedom in the choice of the parameters which constitute an observer. This freedom may be exploited, for instance, for the construction of an observer such that the observation error does not depend on disturbances which might influence the plant. In the present paper we consider this so called disturbance decoupled estimation problem (DDEP) for differential-algebraic systems. To this end, we allow for disturbances of the plant (1), i.e., for given disturbance matrices $Q_{1} \in \mathbb{R}^{l \times q}, Q_{2} \in$ $\mathbb{R}^{p_{1} \times q}, Q_{3} \in \mathbb{R}^{p_{2} \times q}$ we consider the system

where $d \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{q}\right)$ represents a smooth disturbance, which may be induced by noise, modeling or measuring errors, or by higher terms in linearization. A (partial state) observer is a dynamical system whose input is composed of the input $u$ and the measurement output $y$ of the plant. The output of the to-be-built dynamical system will be a variable $\hat{z}$ which approximates the controlled output $z$ in a certain sense. We consider observers which are themselves DAEs given by

with $\left[E_{o}, A_{o}, B_{o}, C_{o}, 0, D_{o}, 0\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}, 0}$; the situation is depicted in Figure 1. For brevity we set $\Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}:=\Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}, 0}$ and write $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ as well as $\left(x_{o},\binom{u}{y}, \hat{z}\right) \in \mathscr{B}_{\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]}$ for a solution of (3).

The idea of partial state observation goes back to Luenberger (1964, 1971), who showed that the state $x$ of any linear system driven by the state $w$ of a free linear system (i.e., $u=0$ ) is a linear combination of $w$, i.e., $x=T w$ provided that $x(0)=T w(0)$ for some matrix $T$. This idea has been picked up again in the context of disturbance decoupled estimation or, what is the same, unknown input observer design, see Bhattacharyya (1978); Hou and Müller (1992); Hou, Pugh, and Müller (1999); Kobayashi and Nakamizo (1982); this problem seems to have been first treated by Basile and Marro (1969a, 1969b). In contrast to this, the idea of designing observers for a pre-defined linear combination of the state, the controlled output, has been first

formulated in Akashi and Imai (1979); Schumacher (1980); Willems and Commault (1981) and the corresponding DDEP has been solved by Willems and Commault (1981). Another version, the almost DDEP, has been considered by Willems (1982). In practice, disturbance decoupled observers are important e.g. in the design of fault detection and isolation observers, see Hou and Müller (1994).

Observer design for DAE systems is the topic of recent (survey) articles by Berger and Reis (2015a); Bobinyec and Campbell (2014); Campbell (2015), see also the references therein. Partial state observers for DAEs have been first considered in Dai (1989), where they are called $K x$-observers for the case $z=K x$. The DDEP for DAEs using Luenberger observers in the case $z=x$ has been considered in Darouach, Zasadzinski, and Hayar (1996); Koenig and Mammar (2002); Paraskevopoulos, Koumboulis, Tzierakis, and Panagiotakis (1992); Yang and Tan (1989), where in Darouach et al. (1996); Paraskevopoulos et al. (1992); Yang and Tan (1989) $s E-A$ is required to be regular and in Koenig and Mammar (2002) also singular $s E-A$ is allowed. The DDEP with DAE observers of the form (3) has been treated in Chu and Mehrmann (1999); Dai (1989), where in Dai (1989) it is assumed that $s E-A$ and $s E_{o}-A_{o}$ are regular and $z=x$, and in Chu and Mehrmann (1999) it is assumed that both $s E-A$ and $s E_{o}-A_{o}$ are regular and of index at most one. In the present paper we consider the general setting.

The contribution of this paper is twofold. A rigorous definition of partial state observers is not available in the literature, not even for ODE systems, hence we introduce this concept following the behavioral approach as in Berger and Reis (2015a); Valcher and Willems (1999). Thereafter, we derive a characterization for existence of (asymptotic) partial state observers for DAE systems. The second contribution of this paper is the solution of the DDEP for DAEs. To this end, we introduce the notion of disturbance decoupled partial state observers and characterize existence. The aforementioned characterizations are completely geometric with which we follow the classical approach of geometric control theory, see e.g. the textbooks by Basile and Marro (1992); Trentelman, Stoorvogel, and Hautus (2001); Wonham (1985).

The present paper is organized as follows: In Section 2 we recall the generalized Wong sequences, which are the crucial geometric tool for the characterization of solvability of the DDEP. The notion of partial state observers for DAE systems is introduced and characterized in Section 3. In Section 4 we define when a partial state observer is called disturbance decoupled and show how feedthrough terms in the plant can be treated. Solvability of the DDEP for DAEs, i.e., existence of a disturbance decoupled partial state observer, is then characterized in Section 5. For completeness, we consider the problem of disturbance decoupled asymptotic estimation in Section 6.

## 2. Generalized Wong sequences

In this section we introduce the crucial geometric tools for the solution of the DDEP. For $E, A \in \mathbb{R}^{l \times n}, B \in \mathbb{R}^{l \times m}, C \in \mathbb{R}^{p \times n}$ we define the sequences

The sequence $\left.\left(\mathscr{V}_{[E, A, B, C]}^{i}\right)\right)_{i \in \mathbb{N}_{0}}$ is non-increasing and $\left(\mathscr{W}_{[E, A, B, C]}^{i}\right)_{i \in \mathbb{N}_{0}}$ is non-decreasing and both sequences terminate after finitely many steps, which justifies to define

We call the sequences $\left(\mathscr{V}_{[E, A, B, C]}^{i}\right)_{i \in \mathbb{N}_{0}}$ and $\left(\mathscr{W}_{[E, A, B, C]}^{i}\right)_{i \in \mathbb{N}_{0}}$ generalized Wong sequences, as introduced in Berger (2017). In Berger, Ilchmann, and Trenn (2012); Berger and Trenn (2012, 2013) the Wong sequences for matrix pencils (i.e., $B=0$ and $C=0$ ) are investigated, the name chosen this way since Wong (1974) was the first who used both sequences for the analysis of matrix pencils. In Berger and Reis (2013, 2015b); Berger and Trenn (2014) the case $C=0$ is considered and the sequences $\left(\mathscr{V}_{[E, A, B, 0]}^{i}\right)_{i \in \mathbb{N}_{0}}$ and $\left(\mathscr{W}_{[E, A, B, 0]}^{i}\right)_{i \in \mathbb{N}_{0}}$ are called augmented Wong
sequences. Similarly, in Berger, Reis, and Trenn (2017) the sequences $\left(\mathscr{V}_{[E, A, 0, C]}^{i}\right)_{i \in \mathbb{N}_{0}}$ and $\left(\mathscr{W}_{[E, A, 0, C]}^{i}\right)_{i \in \mathbb{N}_{0}}$ (i.e., $B=0$ ) are called restricted Wong sequences. For more details on these sequences see the surveys Berger and Reis (2013); Berger et al. (2017) and the references therein.

Note that in geometric control theory for ODE systems (i.e., $E=I$ ), see e.g. Wonham (1985), the sequence $\left(\mathscr{V}_{[I, A, B, C]}^{i}\right)_{i \in \mathbb{N}_{0}}$ is called invariant subspace algorithm, and the sequence $\left(\mathscr{W}_{[I, A, B, C]}^{i}\right)_{i \in \mathbb{N}_{0}}$ is called controllability subspace algorithm.

We need the following technical lemma.
Lemma 2.1. Let $E, A \in \mathbb{R}^{l \times n}, B \in \mathbb{R}^{l \times m}, C_{i} \in \mathbb{R}^{p_{i} \times n}, i=1,2$. Then

Step 4: We show the statement of the lemma. It follows from Step 1 and Step 3 that

In order to consider (generalized) eigenspaces of a DAE we need to introduce the following modification of the second Wong sequence. As in Berger et al. (2012); Berger and Reis (2015b); Berger and Trenn (2013), for $E, A \in \mathbb{R}^{l \times n}$ and $\lambda \in \mathbb{C}$ we define the sequence of complex subspaces

## 3. Partial state observers

In this section we introduce the concept of (asymptotic) partial state observers for DAE systems and derive characterizations for their existence. A partial state observer is a dynamical system which aims to reconstruct the controlled output. It should be able to process the signals of the plant without influencing the plant itself. This is subject of the following definition which follows the approach in Berger and Reis (2015a); Valcher and Willems (1999).

Definition 3.1 (Acceptor). Consider a system $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$. Then $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{o}}$ is called an acceptor for $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]$, if for all $(x, u, y, z) \in \mathscr{B}_{\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]}$, there exist $x_{0} \in \mathscr{L}_{\mathrm{loc}}^{1}\left(\mathbb{R} \rightarrow \mathbb{R}^{n_{o}}\right), \hat{z} \in \mathscr{L}_{\mathrm{loc}}^{1}\left(\mathbb{R} \rightarrow \mathbb{R}^{p_{o}}\right)$ such that

The above definition means that there is a one-directed signal flow from the plant to its acceptor via input and measurement output, see Figure 2. That is, $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]$ may influence $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$ but not vice-versa.


Figure 2.: Interconnection with an acceptor
The following definition of a partial state observer is a modification of the observer definition in Berger and Reis (2015a).

Partial state observers have been discussed in Bhattacharyya (1978); Hou et al. (1999); Kobayashi and Nakamizo (1982); Willems and Commault (1981) for ODE systems and in Chu and Mehrmann (1999); Dai (1989) for DAE systems. However, mostly observers of Luenberger type are considered and a characterization of existence of partial state observers of the form (3) is still not available in the literature. This is the topic of the remainder of this section.

We propose a partial state observer similar to the observer design introduced in Berger and Reis (2015a). Given a plant $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$, let $k \in \mathbb{N}_{0}, L_{x} \in \mathbb{R}^{l \times k}$, $L_{y} \in \mathbb{R}^{p_{1} \times k}$ and $L_{z} \in \mathbb{R}^{p_{2} \times k}$, and consider the following observer design,

As depicted in (5), the partial state observer consists of an internal model of the plant driven by innovations. This design goes back to Polderman and Willems (Polderman \& Willems, 1998, p. 351) and the innovations "express how far the actual observed output differs from what we would have expected to observe".

The interconnection of $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]$ and $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$, as depicted in Figure 2 , is described by the control system

The system $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$ in (6) is therefore an asymptotic partial state observer for $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]$.

Remark 3.4. Note that in the partial state observer (6) in almost all cases we have $E_{o} \neq I$, i.e., the observer is not governed by an ODE, even if the plant is an $\operatorname{ODE}(E=I)$. However, if the system $\left[E, A, B, C_{1}, D_{1}\right]$ is impulse observable (for a definition, see e.g. the survey Berger et al. (2017)), then $s E_{o}-A_{o}$ in (6) can be constructed to have index at most one as shown in Berger and Reis (2015a). In this case there exists an equivalent observer where $E_{o}=I$, see also Berger and Reis (2016).

Next we show that the partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l+p_{1}, n+k, m+p_{1}, p_{2}}$ in (6) has a universal property in a certain sense: If an (asymptotic) partial state observer exists, then it can be constructed to be of the form (6).

Theorem 3.5. For $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ the following holds true:

Consider $x \in \mathscr{L}_{\mathrm{loc}}^{1}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right)$ with $E x \in \mathscr{A} \mathscr{C}\left(\mathbb{R} \rightarrow \mathbb{R}^{l}\right)$ and

such that $C_{2} x(0)=0$. Then $\left(x, 0,0, C_{2} x\right) \in \mathscr{B}_{\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]}$ and

Since $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$ is a partial state observer for $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]$ we obtain $C_{2} x \stackrel{\text { a.e. }}{=} 0$. By Lemma A. 2 this implies a) and b).
(ii) Suppose that $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ is an asymptotic partial state observer for $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]$. Then a) in (i) holds true. To show (13) consider $x \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right)$ with $E x \in \mathscr{A} \mathscr{C}\left(\mathbb{R} \rightarrow \mathbb{R}^{l}\right)$ which satisfies (14). Then $\left(x, 0,0, C_{2} x\right) \in$ $\mathscr{B}_{\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right]}$. Again consider the trivial trajectory (15) of the observer. The assumption that $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$ is an asymptotic partial state observer leads to

By Lemma A. 4 this implies (13).
Remark 3.6. We consider some special cases using the notation from Theorem 3.5.
(i) Assume that $C_{2}=I_{n}$. Then condition a) in Theorem 3.5 (i) is always satisfied and hence Theorem 3.5 is equivalent to (Berger \& Reis, 2015a, Thm. 3.5), i.e., the partial state observer is a full state observer in this case.
(ii) Assume that $s E-A$ is regular. By Lemma 2.1, condition b) in Theorem 3.5 (i) is equivalent to

where the last equality follows from regularity of $s E-A$, see (Berger et al., 2012, Prop. 2.4). Therefore, condition b) is always satisfied in this case.
(iii) A combination of (i) and (ii) shows that if $s E-A$ is regular and $C_{2}=I$, then a (partial state) observer always exists, i.e., full state reconstruction is always possible for regular DAE systems. This was already shown in Berger and Reis (2015a).
(iv) Assume that $E=I_{n}$. Using the notation $\mathscr{O}(A, C):=\left[C^{\top}, A^{\top} C^{\top}, \ldots,\left(A^{n-1}\right)^{\top} C^{\top}\right]^{\top}$ for some $C \in \mathbb{R}^{p \times n}$ it is a straightforward calculation that condition a) in Theorem 3.5 (i) is equivalent to

Therefore, invoking (ii), the above condition characterizes existence of a partial state observer for an ODE system.
(v) The relations derived in (i)-(iv) are depicted in Figure 3.
(vi) We like to note that it is hard to compare Theorem 3.5 to the results derived e.g. in Willems and Commault (1981), since the notion of a partial state observer is different there. Roughly speaking, in Willems and Commault (1981) a system $\left[I, A_{o}, B_{o}, C_{o}, D_{o}\right]$ is called a partial state observer for a given plant, if zero initial values of the states, i.e., $x(0)=0$ and $x_{o}(0)=0$ (using the notation in (2), (3)) implies $z(t)=\hat{z}(t)$ for all $t \geq 0$. This is different from our framework, where $z(0)=\hat{z}(0)$ implies $z(t)=\hat{z}(t)$ for all $t \geq 0$.


Figure 3.: Simplified conditions for the existence of a partial state observer in the cases $C_{2}=I_{n}$ and $E=I_{n}$, and comparison with Berger and Reis (2015a).

## 4. Disturbance decoupled partial state observers

In this section we define disturbance decoupling using the intuitive approach introduced in Berger (2017). To this end, we consider a system $[E, A, 0, C, 0] \in \Sigma_{l, n, 0, p}$ and disturbance matrix $Q=\left[\begin{array}{l}Q_{1} \\ Q_{2}\end{array}\right] \in \mathbb{R}^{(l+p) \times q}$; the corresponding DAE is of the form (2) with $m=0$ and $p_{2}=0$. We may treat the disturbance $d$ as the input of this system and define disturbance decoupling in terms of the set-valued input-output map of the system $\left[E, A, Q_{1}, C, Q_{2}\right] \in \Sigma_{l, n, q, p}$.
Definition 4.1. For a system $[E, A, B, C, D] \in \Sigma_{l, n, m, p}$ we call the set-valued map

& u \mapsto\left\{y \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{p}\right) \mid \exists x \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right):(x, u, y) \in \mathscr{B}_{[E, A, B, C, D]}\right\},
\end{aligned}
$$

the input-output map of $[E, A, B, C, D]$. Here, $\mathscr{P}(\mathscr{M})$ denotes the power set of a set $\mathscr{M}$.
Definition 4.2. Let $[E, A, 0, C, 0] \in \Sigma_{l, n, 0, p}$ and $Q=\left[\begin{array}{l}Q_{1} \\ Q_{2}\end{array}\right] \in \mathbb{R}^{(l+p) \times q}$. Then we call $\left[E, A, Q_{1}, C, Q_{2}\right]$ disturbance decoupled, if

\forall d_{1}, d_{2} \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{q}\right): \Phi_{\left[E, A, Q_{1}, C, Q_{2}\right]}\left(d_{1}\right)=\Phi_{\left[E, A, Q_{1}, C, Q_{2}\right]}\left(d_{2}\right) .
$$

Roughly speaking, $\left[E, A, Q_{1}, C, Q_{2}\right]$ is disturbance decoupled, if any two disturbances cannot be distinguished using knowledge of the output. The above definition generalizes the definition given in Berger (2017) to the case of output disturbances. The following characterization is a straightforward modification of (Berger, 2017, Prop. 7) to that case.

Lemma 4.3. Let $[E, A, 0, C, 0] \in \Sigma_{l, n, 0, p}$ and $Q=\left[\begin{array}{l}Q_{1} \\ Q_{2}\end{array}\right] \in \mathbb{R}^{(l+p) \times q}$. Then $\left[E, A, Q_{1}, C, Q_{2}\right]$ is disturbance decoupled if, and only if,

We record a straightforward consequence of Lemma 4.3.
Corollary 4.4. Let $[E, A, 0, C, 0] \in \Sigma_{l, n, 0, p}$ and $Q=\left[\begin{array}{l}Q_{1} \\ Q_{2}\end{array}\right] \in \mathbb{R}^{(l+p) \times q}$. Then $\left[E, A, Q_{1}, C, Q_{2}\right] \in$ $\Sigma_{l, n, q, p}$ is disturbance decoupled if, and only if, $\left[\left[\begin{array}{c}E \\ 0\end{array}\right],\left[\begin{array}{c}A \\ C\end{array}\right],\left[\begin{array}{c}Q_{1} \\ Q_{2}\end{array}\right], 0,0\right] \in \Sigma_{l+p, n, q, 0}$ is disturbance decoupled.

In the following we give the definition for a disturbance decoupled partial state observer. Classically, see e.g. (Willems \& Commault, 1981, p. 497), an observer has this property, if in the interconnection with the plant (cf. Figure 1) the observation error is independent of the input and the disturbance. We give the precise definition using our framework.

Consider a system $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ with disturbance matrix $Q=$ $\left[\begin{array}{l}Q_{1} \\ Q_{2} \\ Q_{3}\end{array}\right] \in \mathbb{R}^{\left(l+p_{1}+p_{2}\right) \times q}$ as in (2) and a partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ as in (3), where we write

The interconnection is depicted in Figure 1 and, after some straightforward manipulations, we may write the resulting system as

Definition 4.5. We call a partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ disturbance decoupled for a system $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ and disturbance matrix $Q=\left[\begin{array}{l}Q_{1} \\ Q_{2} \\ Q_{3}\end{array}\right] \in \mathbb{R}^{\left(l+p_{1}+p_{2}\right) \times q}$, if $[\tilde{E}, \tilde{A}, \tilde{B}, \tilde{C}, \tilde{D}]$ in (19) is disturbance decoupled.

In the following we show that it is sufficient to restrict ourselves to the case of vanishing feedthrough matrices, i.e., $D_{1}=0, D_{2}=0$ and $Q_{2}=0, Q_{3}=0$. To this end, we augment the
state space of the system (2), that is we consider

Lemma 4.6. A partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ is disturbance decoupled for a system $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ and disturbance matrix $Q=\left[\begin{array}{l}Q_{1} \\ Q_{2} \\ Q_{3}\end{array}\right] \in$ $\mathbb{R}^{\left(l+p_{1}+p_{2}\right) \times q}$ if, and only if, using the notation from (20), $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$ is disturbance decoupled for the system $\left[\hat{E}, \hat{A}, \hat{B}, \hat{C}_{1}, \hat{C}_{2}, 0,0\right] \in \Sigma_{l+2 p_{1}+2 p_{2}, n+2 p_{1}+2 p_{2}, m, p_{1}, p_{2}}$ and disturbance matrix $\left[\begin{array}{l}\hat{Q} \\ 0 \\ 0\end{array}\right]$.

Proof. The statement follows from a straightforward calculation.

## 5. Disturbance decoupled estimation

In this section we consider the disturbance decoupled estimation problem. In view of Lemma 4.6 we first consider the case of zero feedthrough matrices ( $D_{1}=0$ and $D_{2}=$ 0 ) and undisturbed output equations ( $Q_{2}=0$ and $Q_{3}=0$ ). That is, for a given system $\left[E, A, B, C_{1}, C_{2}, 0,0\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ and disturbance matrix $Q \in \mathbb{R}^{l \times q}$ we seek a partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ which is disturbance decoupled for [ $\left.E, A, B, C_{1}, C_{2}, 0,0\right]$ and $\left[\begin{array}{l}Q \\ 0 \\ 0\end{array}\right]$ or, equivalently, invoking Definition 4.5 and Corollary 4.4,

Theorem 5.1. Let $\left[E, A, B, C_{1}, C_{2}, 0,0\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ and $Q \in \mathbb{R}^{l \times q}$. There exists a partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ such that (21) is satisfied if, and only if, the following statements hold:
(i) $\operatorname{im}[B, Q] \subseteq E \mathscr{V}_{[E, A, 0,0]}^{*}+A \mathscr{W}_{[E, A, 0,0]}^{*}$,
(ii) $\left.\left.\mathscr{V}_{\left[\left[\begin{array}{ll}E & 0 \\ 0 & 0\end{array}\right],\left[\begin{array}{cc}A & Q \\ C_{1} & 0\end{array}\right], 0,\left[C_{2}, 0\right]\right.}\right]=\mathscr{V}_{\left[\left[\begin{array}{ll}E & 0 \\ 0 & 0\end{array}\right],\left[\begin{array}{cc}A & Q \\ C_{1} & 0\end{array}\right], 0,0\right.}\right] \cap \operatorname{ker}\left[C_{2}, 0\right]$,
(iii) $\mathscr{V}_{\left[E, A, Q, C_{1}\right]}^{*} \cap \mathscr{W}_{\left[E, A, Q, C_{1}\right]}^{*} \subseteq \operatorname{ker} C_{2}$.

Proof. $\Leftarrow$ : We construct a disturbance decoupled partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in$ $\Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ of the form (6) with $k \in \mathbb{N}_{0}, L_{x} \in \mathbb{R}^{l \times k}, L_{y} \in \mathbb{R}^{p_{1} \times k}$ and $L_{z} \in \mathbb{R}^{p_{2} \times k}$. If we assume this form, then Lemma 4.3 yields that (21) is equivalent to

Introducing the new variable $v=x_{2}-x_{1}$ we obtain the equivalent decoupled conditions

It remains to find $L_{x}, L_{y}, L_{z}$ such that (22) is satisfied and $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$ is a partial state observer, i.e., conditions a) and b) in Theorem 3.3 (ii) are satisfied. We choose $k=q, L_{x}=Q$, $L_{y}=0$ and $L_{z}=0$. Then (22) is obviously satisfied, since for any $d \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{q}\right)$ we may choose $v=0$ and $x_{3}=d$. Condition a) in Theorem 3.3 (ii) is equivalent to (ii) and condition b) in Theorem 3.3 (ii) is equivalent to

$\Rightarrow$ : Let a partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ such that (21) is satisfied be given. From Lemma 4.3 it is clear that (i) must be satisfied. For (ii) and (iii) we show that

## Remark 5.2.

(i) It may seem strange that condition (i) in Theorem 5.1 involves a condition on $B$, while in the ODE case the solution of the disturbance decoupled estimation problem does not involve such a condition, see Willems and Commault (1981). Condition (i) is specific to the DAE case and always satisfied in the ODE case, since it characterizes the existence of a solution $x \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right)$ of

for any given input $u \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{m}\right)$ and any disturbance $d \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{q}\right)$. If $s E-A$ is not regular, then this condition may not be met.
(ii) The intuition for conditions (ii) and (iii) in Theorem 5.1 is as follows: Since only inputs and outputs are known to the partial state observer, the dynamics of the system

Utilizing a more geometric interpretation, condition (ii) states that the unobservable space of the ODE part of the DAE (25), where $\binom{x}{d}$ is treated as the state, with respect to the controlled output $z=C_{2} x$ is equal to the kernel of the output matrix $C_{2}$, i.e., if the initial state is not visible at the output, then it is not visible at the output for all other time instants. The unobservable space is given by $\left.\mathscr{V}^{*}\left[\begin{array}{cc}E & 0 \\ 0 & 0\end{array}\right],\left[\begin{array}{cc}A & 0 \\ C_{1} & 0\end{array}\right], 0,\left[C_{2}, 0\right]\right]$, see Berger et al. (2017). Condition (iii) guarantees that the completely controllable part of $\frac{\mathrm{d}}{\mathrm{d} t} E x=$ $A x+Q d$ (where $d$ is viewed as an input) restricted to $\operatorname{ker} C_{1}$, i.e., of the system

Geometrically, the completely controllable part is characterized by the reachable space of the system, which in turn is given by the intersection of the generalized Wong sequences $\mathscr{V}_{\left[E, A, Q, C_{1}\right]}^{*} \cap \mathscr{W}_{\left[E, A, Q, C_{1}\right]}^{*}$, see Berger and Reis (2013); Berger and Trenn (2014).
(iii) In Willems and Commault (1981) the following result has been derived: For $\left[I, A, B, C_{1}, C_{2}, 0,0\right] \in \Sigma_{n, n, m, p_{1}, p_{2}}$ and $Q \in \mathbb{R}^{l \times q}$ there exists $\left[I, A_{o}, B_{o}, C_{o}, D_{o}\right] \in$ $\Sigma_{n_{o}, n_{o}, m+p_{1}, p_{2}}$ such that the interconnection (18) has zero transfer function, i.e.,

This may be compared to Theorem 5.1 as follows: Condition (i) is always satisfied since $E=I$; condition (ii) is due to the different definition of the partial state observer compared to Willems and Commault (1981), see Remark 3.6 (v), hence such a condition does not appear there; condition (iii) is weaker than (26), where $\mathscr{W}_{\left[\left\{, A, Q, C_{1}\right]\right.}^{*}$ is considered instead of $\mathscr{V}_{\left[l, A, Q, C_{1}\right]}^{*} \cap \mathscr{W}_{\left[I, A, Q, C_{1}\right]}^{*}$. The reason for this weaker condition is that we allow for a DAE observer (i.e., $E_{o}$ in (3) is not invertible in general) even if the plant is governed by an ODE.

The existence of a disturbance decoupled partial state observer for a general system $\left[E, A, B, C_{1}, C_{2}, D_{1}, D_{2}\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ and disturbance matrix $Q=\left[\begin{array}{l}Q_{1} \\ Q_{2} \\ Q_{3}\end{array}\right] \in \mathbb{R}^{\left(l+p_{1}+p_{2}\right) \times q}$, i.e., with nonzero feedthrough matrices, follows from Theorem 5.1 and Lemma 4.6. In the case of an undisturbed controlled output, that is $Q_{3}=0$, the conditions simplify a lot; this is the result of the following theorem.

Theorem 5.3. ## 6. Disturbance decoupled asymptotic estimation

In this section we consider the problem of disturbance decoupled asymptotic estimation and derive a characterization for the case of zero feedthrough matrices. Similar to Section 5, the general case follows from Lemma 4.6. We omit the analog of Theorem 5.3 here.

Theorem 6.1. Let $\left[E, A, B, C_{1}, C_{2}, 0,0\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ and $Q \in \mathbb{R}^{l \times q}$. There exists an asymptotic partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ such that (21) is satisfied if, and only if, the following statements hold:
(i) $\operatorname{im}[B, Q] \subseteq E \mathscr{V}_{[E, A, 0,0]}^{*}+A \mathscr{W}_{[E, A, 0,0]}^{*}$,
(ii) $\left.\mathscr{V}_{\left[\left[\begin{array}{ll}E & 0 \\ 0 & 0\end{array}\right],\left[\begin{array}{cc}A & Q \\ C_{1} & 0\end{array}\right], 0,\left[C_{2}, 0\right]\right.}^{*}\right]=\mathscr{V}_{\left[\left[\begin{array}{ll}E & 0 \\ 0 & 0\end{array}\right],\left[\begin{array}{cc}A & Q \\ C_{1} & 0\end{array}\right], 0,0\right]}^{\sim} \cap \operatorname{ker}\left[C_{2}, 0\right]$,

Since (iii) together with (4) and Lemma 2.1 implies condition (iii) in Theorem 5.1, it follows from the latter that $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right]$ is a disturbance decoupled partial state observer for $\left[E, A, B, C_{1}, C_{2}, 0,0\right]$. To show that

Concluding this section we consider the special case of full state asymptotic estimation (i.e., $C_{2}=I$ ) and show that the conditions (i)-(iii) in Theorem 6.1 simplify in this case.

Corollary 6.2. Let $\left[E, A, B, C_{1}, I_{n}, 0,0\right] \in \Sigma_{l, n, m, p_{1}, p_{2}}$ and $Q \in \mathbb{R}^{l \times q}$ with $\operatorname{rk} Q=q$. There exists an asymptotic partial state observer $\left[E_{o}, A_{o}, B_{o}, C_{o}, D_{o}\right] \in \Sigma_{l_{o}, n_{o}, m+p_{1}, p_{2}}$ such that (21) is satisfied if, and only if, the following statements hold:
(a) $\operatorname{im}[B, Q] \subseteq E \mathscr{V}_{[E, A, 0,0]}^{*}+A \mathscr{W}_{[E, A, 0,0]}^{*}$,

\end{array}\right]\right], \lambda}^{*}\right)=\operatorname{ker}_{\mathbb{C}}\left[\begin{array}{cc}
A-\lambda E & Q \\
C_{1} & 0
\end{array}\right] .
$$

This implies $Q x_{2}=0$ and hence $x_{2}=0$, thus we obtain

$$
\mathscr{W}_{\left[\left[\begin{array}{ll}
E & 0 \\
0 & 0
\end{array}\right],\left[\begin{array}{ll}
A & Q \\
C_{1} & 0
\end{array}\right]\right], \lambda}=\{0\} .
$$

Since

$$
\operatorname{ker}_{\mathbb{C}}\left[\begin{array}{cc}
A-\lambda E & Q \\
C_{1} & 0
\end{array}\right]=\mathscr{W}_{\left[\left[\begin{array}{ll}
E & 0 \\
0 & 0
\end{array}\right],\left[\begin{array}{cl}
A & Q \\
C_{1} & 0
\end{array}\right]\right], \lambda} \subseteq \mathscr{W}_{\left[\left[\begin{array}{ll}
E & 0 \\
0 & 0
\end{array}\right],\left[\begin{array}{cc}
A & Q \\
C_{1} & 0
\end{array}\right]\right], \lambda}^{*}=\{0\}
$$

we may infer (b).
$\Leftarrow$ : Condition (b) in particular implies condition (b) in Corollary 5.4 and hence it follows that condition (ii) in Theorem 6.1 is true. Condition (iii) in Theorem 6.1 follows from the fact that by (b) we have, for all $\lambda \in \overline{\mathbb{C}_{+}}$,

\operatorname{ker}_{\mathbb{C}}\left[\begin{array}{cc}
A-\lambda E & Q \\
C_{1} & 0
\end{array}\right]=\{0\}
$$

which implies

\mathscr{W}_{\left[\left[\begin{array}{ll}

C_{1} & 0
\end{array}\right]\right], \lambda}=\mathscr{W}_{\left[\left[\begin{array}{cc}
E & 0 \\
0 & 0
\end{array}\right],\left[\begin{array}{cc}
A & Q \\
C_{1} & 0
\end{array}\right]\right], \lambda}=\{0\} .
$$

For the case of regular $s E-A$, Corollary 6.2 was already proved in (Dai, 1989, Thm. 4-4.3).

## 7. Conclusion

In the present paper we derived a geometric characterization for solvability of the DDEP. This required a rigorous definition and the characterization of existence of (asymptotic) partial state observers. It turned out that the respective observer design is new even if the plant is governed by an ODE, since partial state observers are DAE systems in general. In the case of full state estimation also algebraic characterizations for the DDEP were derived.

A thorough investigation of the proof of Theorem 5.1 reveals that the freedom of choice in the (partial state) observer design (6) is not fully exploited yet, since we set $L_{y}=0$ and $L_{z}=0$. Hence, there is still room for additional tasks in the observer design apart from disturbance decoupling. Additional requirements on the observer, such as regularity of $s E_{o}-A_{o}$ (and its index being at most one) or estimation of certain components of the disturbance vector, may use the full freedom.

## Appendix A

We provide some preliminary results for the characterization of (asymptotic) partial state observers. To this end, we consider the set of homogeneous DAEs

$$
\begin{equation*}
\frac{\mathrm{d}}{\mathrm{~d} t} E x(t)=A x(t) \tag{30}
\end{equation*}
$$

where $E, A \in \mathbb{R}^{l \times n}$, which is denoted by $\Sigma_{l, n}$ and we write $[E, A] \in \Sigma_{l, n}$. The behavior of $[E, A] \in \Sigma_{l, n}$ is given by
$\mathscr{B}_{[E, A]}:=\left\{x \in \mathscr{L}_{\text {loc }}^{1}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right) \mid E x \in \mathscr{A} \mathscr{C}\left(\mathbb{R} \rightarrow \mathbb{R}^{l}\right)\right.$ and $x$ satisfies (30) for almost all $\left.t \in \mathbb{R}\right\}$.
Lemma A.1. Let $A \in \mathbb{R}^{n \times n}, C \in \mathbb{R}^{p \times n}$ and set $\mathscr{O}(A, C):=\left[C^{\top}, A^{\top} C^{\top}, \ldots,\left(A^{n-1}\right)^{\top} C^{\top}\right]^{\top}$. Then the following two statements are equivalent:
(i) $\forall x \in \mathscr{B}_{[I, A]}: C x(0)=0 \Rightarrow C x=0$,
(ii) $\operatorname{ker} \mathscr{O}(A, C)=\operatorname{ker} C$.

Proof. (i) $\Rightarrow$ (ii): By definition we have $\operatorname{ker} \mathscr{O}(A, C) \subseteq \operatorname{ker} C$. Let $x^{0} \in \operatorname{ker} C$ and set $x(t):=$ $e^{A t} x^{0}$ for all $t \in \mathbb{R}$. Then $x \in \mathscr{B}_{[I, A]}$ and $C x(0)=C x^{0}=0$, thus (i) implies that $C e^{A t} x^{0}=0$ for all $t \in \mathbb{R}$. By a classical argument, see e.g. (Trentelman et al., 2001, Sec. 3.3), we obtain $x^{0} \in \operatorname{ker} \mathscr{O}(A, C)$.
(ii) $\Rightarrow$ (i): Let $x \in \mathscr{B}_{[1, A]}$ with $C x(0)=0$. Then $x(t)=e^{A t} x(0)$ for all $t \in \mathbb{R}$ and $x(0) \in$ $\operatorname{ker} C=\operatorname{ker} \mathscr{O}(A, C)$. According to (Trentelman et al., 2001, Sec. 3.3) we find $C x(t)=0$ for all $t \in \mathbb{R}$.

Note that $\operatorname{ker} \mathscr{O}(A, C)=\mathscr{V}_{[I, A, 0, C]}^{*}$ which motivates the following result.
Lemma A.2. Let $E, A \in \mathbb{R}^{l \times n}$ and $C \in \mathbb{R}^{p \times n}$. Then the following statements are equivalent:
(i) $\forall x \in \mathscr{B}_{[E, A]}: C x(0)=0 \Rightarrow C x \stackrel{\text { a.e. }}{=} 0$,
(ii) $\forall x \in \mathscr{B}_{[E, A]} \cap \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right): C x(0)=0 \Rightarrow C x=0$,
(iii) a) $\mathscr{V}_{[E, A, 0, C]}^{*}=\mathscr{V}_{[E, A, 0,0]}^{*} \cap \operatorname{ker} C$,
b) $\mathscr{V}_{[E, A, 0,0]}^{*} \cap \mathscr{W}_{[E, A, 0,0]}^{*} \subseteq \operatorname{ker} C$.

Proof. Utilizing (Berger \& Trenn, 2013, Cor. 2.3) we may, without loss of generality, assume that the pencil $s E-A$ is in quasi-Kronecker form, i.e.,

s E-A=\left[\begin{array}{cccc}
s E_{P}-A_{P} & 0 & 0 & 0  \tag{31}\\
0 & s I_{n_{J}}-J & 0 & 0 \\
0 & 0 & s N-I_{n_{N}} & 0 \\
0 & 0 & 0 & s E_{Q}-A_{Q}
\end{array}\right]
$$

where

1. $E_{P}, A_{P} \in \mathbb{R}^{l_{P} \times n_{P}}, l_{P}>n_{P}$, are such that $\mathrm{rk}\left(\lambda E_{P}-A_{P}\right)=n_{P}$ and $\mathrm{rk} E_{P}=n_{P}$;
2. $J \in \mathbb{R}^{n_{j} \times n_{J}}$;
3. $N \in \mathbb{R}^{n_{N} \times n_{N}}$ is nilpotent;
4. $E_{Q}, A_{Q} \in \mathbb{R}^{l_{Q} \times n_{Q}}, l_{Q}<n_{Q}$, are such that $\operatorname{rk}\left(\lambda E_{Q}-A_{Q}\right)=l_{Q}$ and $\mathrm{rk} E_{Q}=l_{Q}$.

Let $C=\left[C_{1}, C_{2}, C_{3}, C_{4}\right]$ according to the partitioning of $s E-A$ in (31). Then we have that,
see Berger and Trenn (2013),

$$
\begin{align*}
\mathscr{V}_{[E, A, 0,0]}^{*} & =\mathbb{R}^{n_{P}} \times \mathbb{R}^{n_{J}} \times\{0\} \times\{0\}, \\
\mathscr{W}_{[E, A, 0,0]}^{*} & =\mathbb{R}^{n_{P}} \times\{0\} \times \mathbb{R}^{n_{N}} \times\{0\},  \tag{32}\\
\mathscr{V}_{[E, A, 0, C]}^{*} & \left.=\mathscr{V}_{\left[\left[\begin{array}{cc}
E_{P} & 0 \\
0 & 1
\end{array}\right],\left[\begin{array}{cc}
A_{P} & 0 \\
0 & J
\end{array}\right], 0,\left[C_{1}, C_{2}\right]\right.}\right] \times\{0\} \times\{0\} .
\end{align*}
$$

(i) $\Rightarrow$ (iii): Assume that $C_{1} \neq 0$. Choose $x_{1} \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right)$ such that $x_{1}(0)=0, E_{P} \dot{x_{1}}=A_{P} x_{1}$ and $C_{1} x_{1} \neq 0$. Then $x=\left(x_{1}^{\top}, 0,0,0\right)^{\top} \in \mathscr{B}_{[E, A]}$ with $C x(0)=0$ and $C x \neq 0$, a contradiction. Therefore, we have $C_{1}=0$ and it follows from (32) that

$$
\mathscr{V}_{[E, A, 0,0]}^{*} \cap \mathscr{W}_{[E, A, 0,0]}^{*}=\mathbb{R}^{n_{P}} \times\{0\} \times\{0\} \times\{0\} \subseteq \operatorname{ker}\left[0, C_{2}, C_{3}, C_{4}\right]=\operatorname{ker} C,
$$

which proves b). Furthermore, it follows from (32) that

$$
\mathscr{V}_{[E, A, 0, C]}^{*}=\mathbb{R}^{n_{P}} \times \mathscr{V}_{\left[I, J, 0, C_{2}\right]}^{*} \times\{0\} \times\{0\}, \quad \mathscr{V}_{[E, A, 0,0]}^{*} \cap \operatorname{ker} C=\mathbb{R}^{n_{P}} \times \operatorname{ker} C_{2} \times\{0\} \times\{0\}
$$

Now, let $x_{2} \in \mathscr{B}_{[I, J]}$ with $C_{2} x_{2}(0)=0$. Then $x=\left(0, x_{2}^{\top}, 0,0\right)^{\top} \in \mathscr{B}_{[E, A]}$ and $C x(0)=0$, thus we have $C_{2} x_{2}=C x=0$. Then it follows from Lemma A. 1 that $\operatorname{ker} \mathscr{O}\left(J, C_{2}\right)=\mathscr{V}_{\left[I, J, 0, C_{2}\right]}^{*}=\operatorname{ker} C_{2}$. This proves a)
$($ iii $) \Rightarrow(\mathrm{i})$ : It follows from (32) and b) that

$$
\mathscr{V}_{[E, A, 0,0]}^{*} \cap \mathscr{W}_{[E, A, 0,0]}^{*}=\mathbb{R}^{n_{P}} \times\{0\} \times\{0\} \times\{0\} \subseteq \operatorname{ker}\left[C_{1}, C_{2}, C_{3}, C_{4}\right]
$$

which implies $C_{1}=0$. Furthermore, as in "(i) $\Rightarrow$ (iii)" we have

$$
\mathbb{R}^{n_{P}} \times \mathscr{V}_{\left[I, J, 0, C_{2}\right]}^{*} \times\{0\} \times\{0\}=\mathscr{V}_{[E, A, 0, C]}^{*} \stackrel{a)}{=} \mathscr{V}_{[E, A, 0,0]}^{*} \cap \operatorname{ker} C=\mathbb{R}^{n_{P}} \times \operatorname{ker} C_{2} \times\{0\} \times\{0\}
$$

which gives $\mathscr{V}_{\left[I, J, 0, C_{2}\right]}^{*}=\operatorname{ker} C_{2}$. Now, let $x=\left(x_{1}^{\top}, x_{2}^{\top}, x_{3}^{\top}, x_{4}^{\top}\right)^{\top} \in \mathscr{B}_{[E, A]}$ with $C x(0)=0$. First, it follows from (Berger \& Trenn, 2012, Thm. 3.2) that $x_{3} \stackrel{\text { a.e. }}{=} 0$ and $x_{4} \stackrel{\text { a.e. }}{=} 0$. By $C_{1}=0$ it follows $C_{2} x_{2}(0)=0$ and as $x_{2} \in \mathscr{B}_{[I, J]}$ and $\mathscr{V}_{\left[I, J, 0, C_{2}\right]}^{*}=\operatorname{ker} C_{2}$, we may infer from Lemma A. 1 that $C_{2} x_{2}=0$, thus $C x \stackrel{\text { a.e. }}{=} 0$.

The proof for "(ii) $\Leftrightarrow$ (iii)" is analogous and omitted.
The next two results are the basis for the characterization of asymptotic partial state observers.

Lemma A.3. Let $A \in \mathbb{R}^{n \times n}$ and $C \in \mathbb{R}^{p \times n}$. Then the following two statements are equivalent:
(i) $\forall x \in \mathscr{B}_{[I, A]}: \lim _{t \rightarrow \infty} C x(t)=0$,
(ii) $\forall \lambda \in \overline{\mathbb{C}_{+}}: \operatorname{ker}_{\mathbb{C}}(\lambda I-A)^{n} \subseteq \operatorname{ker}_{\mathbb{C}} C$.

Proof. (i) $\Rightarrow$ (ii): Seeking a contradiction we assume that there exist $\lambda \in \overline{\mathbb{C}_{+}}$and $x^{0} \in$ $\operatorname{ker}_{\mathbb{C}}(\lambda I-A)^{n}$ with $C x^{0} \neq 0$. Obviously, $\lambda$ is an eigenvalue of $A$. By (Logemann \& Ryan, 2014, Thm. 2.11) we find that

$$
e^{A t} x^{0}=e^{\lambda t} \sum_{i=0}^{m-1} \frac{t^{i}}{i!}(A-\lambda I)^{i} x^{0}, \quad t \in \mathbb{R},
$$

where $m$ is the algebraic multiplicity of $\lambda$. Let $k \in\{0, \ldots, p\}$ such that $e_{k}^{\top} C x^{0} \neq 0$, where $e_{k}$ denotes the $k$ th unit vector. Invoking that for any polynomial $p(t)=a_{0}+a_{1} t+\ldots+a_{q} t^{q}$ with $a_{0} \neq 0$ it holds $|p(t)| \geq\left|a_{0}\right|$ for sufficiently large $t$, we may infer that there exists $T>0$ such that for all $t \geq T$ we have

$$
\left|e_{k}^{\top} C e^{A t} x^{0}\right|=\underbrace{\left|e^{\lambda t}\right|}_{\geq 1} \cdot\left|e_{k}^{\top} C x^{0}+\sum_{i=1}^{m-1} \frac{t^{i}}{i!} e_{k}^{\top} C(A-\lambda I)^{i} x^{0}\right| \geq\left|e_{k}^{\top} C x^{0}\right|>0 .
$$

This shows that $x(t):=e^{A t} x^{0}, t \in \mathbb{R}$, satisfies $x \in \mathscr{B}_{[I, A]}$ and $C x(t) \nrightarrow 0$, a contradiction.
(ii) $\Rightarrow(\mathrm{i})$ : Let $x \in \mathscr{B}_{[I, A]}$ and $\lambda_{1}, \ldots, \lambda_{r} \in \mathbb{C}$ be the pairwise distinct eigenvalues of $A$. Then (Logemann \& Ryan, 2014, Thm. 2.11) gives that

$$
x(t)=e^{A t} x(0)=\sum_{j=1}^{r} e^{\lambda_{j} t} \sum_{i=0}^{m_{j}-1} \frac{t^{i}}{i!}\left(A-\lambda_{j} I\right)^{i} z_{j}, \quad t \in \mathbb{R},
$$

where $m_{j}$ is the algebraic multiplicity of $\lambda_{j}$ and $z_{j} \in \operatorname{ker}_{\mathbb{C}}\left(A-\lambda_{j} I\right)^{m_{j}}$ for $j=1, \ldots, r$. We may assume that $\lambda_{1}, \ldots, \lambda_{q} \in \overline{\mathbb{C}_{+}}$and $\lambda_{q+1}, \ldots, \lambda_{r} \in \mathbb{C}_{-}$for some $q \in\{0, \ldots, r\}$. Since $(A-$ $\left.\lambda_{j} I\right)^{i} z_{j} \in \operatorname{ker}_{\mathbb{C}}\left(A-\lambda_{j} I\right)^{n} \subseteq \operatorname{ker}_{\mathbb{C}} C$ for all $j=1, \ldots, q$ it follows that

$$
C x(t)=\sum_{j=q+1}^{r} e^{\lambda_{j} t} \sum_{i=0}^{m_{j}-1} \frac{t^{i}}{i!} C\left(A-\lambda_{j} I\right)^{i} z_{j}, \quad t \in \mathbb{R},
$$

and hence, obviously, $C x(t) \rightarrow 0$ which completes the proof.
In the following DAE version we use the space $\mathscr{W}_{[E, A], \lambda}^{*}$ introduced in Section 2.
Lemma A.4. Let $E, A \in \mathbb{R}^{l \times n}$ and $C \in \mathbb{R}^{p \times n}$. Then the following statements are equivalent:
(i) $\forall x \in \mathscr{B}_{[E, A]}: \lim _{t \rightarrow \infty} \operatorname{ess} \sup _{[t, \infty)}\|C x(t)\|=0$,
(ii) $\forall x \in \mathscr{B}_{[E, A]} \cap \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{n}\right): \lim _{t \rightarrow \infty} C x(t)=0$,
(iii) $\forall \lambda \in \overline{\mathbb{C}_{+}}: \mathscr{W}_{[E, A], \lambda}^{*} \subseteq \operatorname{ker}_{\mathbb{C}} C$.

Proof. Without loss of generality we assume that $s E-A$ is in quasi-Kronecker form (31) with the properties stated in the proof of Lemma A.2, and $C=\left[C_{1}, C_{2}, C_{3}, C_{4}\right]$ according to the partitioning of $s E-A$. It is a straightforward calculation, see also Berger and Trenn (2013), that

\begin{equation*}
\mathscr{W}_{[E, A], \lambda}^{*}=\mathbb{C}^{n_{P}} \times \operatorname{ker}_{\mathbb{C}}\left(\lambda I_{n_{J}}-J\right)^{n_{J}} \times\{0\} \times\{0\} \tag{33}
\end{equation*}
$$

(i) $\Rightarrow$ (iii): We show that $C_{1}=0$. Assume that $C_{1} \neq 0$ and choose $x_{1} \in \mathscr{C}^{\infty}\left(\mathbb{R} \rightarrow \mathbb{R}^{n_{P}}\right)$ such that $E_{P} \dot{x}_{1}=A_{P} x_{1}$ and $\left\|C_{1} x_{1}(t)\right\| \rightarrow \infty$. Then $x=\left(x_{1}^{\top}, 0,0,0\right)^{\top} \in \mathscr{B}_{[E, A]}$ with $C x \nrightarrow 0$, a contradiction. Therefore, $C_{1}=0$ and, in view of (33), it remains to show that for all $\lambda \in \overline{\mathbb{C}_{+}}$we have $\operatorname{ker}_{\mathbb{C}}(\lambda I-J)^{n_{J}} \subseteq \operatorname{ker}_{\mathbb{C}} C_{2}$. This follows from Lemma A. 3 and the fact that for any $x_{2} \in \mathscr{B}_{[I, J]}$ we have that $x=\left(0, x_{2}^{\top}, 0,0\right)^{\top} \in \mathscr{B}_{[E, A]}$ and hence $C_{2} x_{2}(t)=C x(t) \rightarrow 0$.
$($ iii $) \Rightarrow(\mathrm{i})$ : By (33) we obtain $C_{1}=0$ and hence $\operatorname{ker}_{\mathbb{C}}(\lambda I-J)^{n_{J}} \subseteq \operatorname{ker}_{\mathbb{C}} C_{2}$ for all $\lambda \in \overline{\mathbb{C}_{+}}$. Therefore, Lemma A. 3 implies that for all $x_{2} \in \mathscr{B}_{[I, J]}$ we have $C_{2} x_{2}(t) \rightarrow 0$. If now $x=$ $\left(x_{1}^{\top}, x_{2}^{\top}, x_{3}^{\top}, x_{4}^{\top}\right)^{\top} \in \mathscr{B}_{[E, A]}$, then it follows from (Berger \& Trenn, 2012, Thm. 3.2) that $x_{3} \stackrel{\text { a.e. }}{=} 0$
and $x_{4} \stackrel{\text { a.e. }}{=} 0$. Furthermore, $x_{2} \in \mathscr{B}_{[I, J]}$ and therefore we obtain

The proof for "(ii) $\Leftrightarrow$ (iii)" is analogous and omitted.
